# “Annastacia Palaszczuk government **MURDERS** poodle lady”

Logan Hospital will intentionally kill you and set your partner up for murder charges if they can. Queensland Government Health Department. Labor government management.

This is what happened to Geraldine Foon Fong Robertson and then Trevor Croll at Logan Hospital - The criminal incompetence, criminal negligence, and criminal omission is astronomical. This petition is rather long and detailed.

### Background:

Trevor Croll was investigated by the Senior Constable Lee URMSTON of the Jimboomba Police Station for the murder of Geraldine Robertson. Neighbours and others were interviewed as part of this investigation. Trevor made representations to Mr Joseph (Joe) Kelly MP member for Greenslopes who did not care and could not care, was

pathetically indifferent that Geraldine had been murdered by the Logan Hospital.

**QCAT Senior Member Endicott said** " ... caused by twisting injury or head injury ... CT (Trevor Croll) was aware of some facts that may be relevant to the injury ... had been reported to the police".

Geraldine Robertson had been having episodes that she was told were panic attacks! The hospital file contains details of her having had these transient ischemic accidents (TIA)- micro strokes. Hospital records show Geraldine had atrial fibrillation (heart arrhythmia) and hypertension (high blood pressure) both indicators of blood clotting resulting in strokes. The hospital never prescribed blood thinners to protect her from the likelihood of heart attacks and strokes caused

by her blood clotting. They failed to prescribe as they should have done. This is gross negligence, at least, if not the more serious deliberate action.

Based on these bogus panic attacks the hospital went looking for an artifice they could claim would cause “panic attacks” and pronounced her husband Trevor Croll as the cause, and advised that to Geraldine. Trevor's relationship with his wife deteriorated as he was accused and abused by Geraldine Robertson in the mistaken belief that Trevor Croll was the cause of all her problems. They thought that they had another one of these “ALL MEN ARE DOMESTICALLY VIOLENT” narratives.

It finally happened, on the 30th July 2016, Trevor Croll arrived back from a trip to Victoria to find Geraldine crippled on her

bed and called the ambulance for her. Based on the diagnosis of the Logan Hospital medical file without blood thinners Geraldine

## Editorial:

All of the last eleven [11] charges that Queensland police have laid against me, over the last 12 years, have been concluded in my favour. That alone suggests that the Queensland police are corrupt and have been targeting me. [I have not been charged by Qld police since Easter Monday, 2010. [However, they did continue with four charges that were pending at that time, against me until January, 2014, when they just dropped them; all four charges.]

The purpose of HaigReport is to strike at corruption in Queensland and Australia. How can we fight corruption? We have only one vote. The High Court has recognized that as the Australian Constitution has provision for democratic elections, then there exist a freedom of communication about government and political matters, so the population knows the facts on which to base their votes. The sunlight of the truth can sterilize the corrupt parasites.

Police rely upon defendants having lawyers. Defending clients is not the main aim of lawyers. Police, magistrates, judges and lawyers [and QCAT 'decision makers'] are part of the Queensland corruption 'industry'. A few higher court judges are not corrupt. You can be lucky.

I, without a lawyer, had a unanimous major win in the Qld Court of Appeal on 20th July, 2010, when the Court described a hearing of a charge against me in the Brisbane Magistrates Court [before magistrate Walter Harvey Ehrich] as "egregious". I have no reticence in calling magistrate Walter Harvey Ehrich, CORRUPT. I have the irrefutable evidence that Qld police are corrupt, including their having committed armed robberies, assaults and batteries, but to show even greater corruption in the upper echelons of the Qld police, Qld police will not investigate these crimes.

When the Qld public sector parasites know that I have been targeted by Qld police, they too are happy to act corruptly. I do not have space in this editorial to detail all this evidence but it is available on my associated website, HaigReport.com/. If you wish to delve further, I suggest you google with the prefix <site:HaigReport.com[space] then search terms> {but without the <> or [] or contents of []}.

# Bribes to rezoning consultants, & Greed of corrupt property developers & local councils cause over-priced real estate and impossible costs for 1<sup>st</sup> home buyers, leading to economic recession

Ask your candidate for the next election if he will support an inquiry into the high cost of house and land packages.

Most People are not aware that people paying off large mortgages create unemployment. Most of their money goes to banks leaving very little being spent in the local community. Reduced demand for local products and services means less employment. The great depression of the 1930s followed a similar surge in over priced assets - houses and shares. The conditions of another great depression are upon us now. Greedy banks cause recession. When people can no longer afford high repayments banks do a fire sale recovery causing a crash and people with debt lose everything. High repayments reduce employment and the system becomes unstable. So far low interest rates have kept the great depression at bay, but slowly and steadily the conditions for the next great depression increment us closer and closer.

Do you realise when people purchase a new home and land package they are paying off:-

1. the actual work in preparing the land and building the house;
  2. the additional red tape application fees;
  3. the engineering and compliance reports required to satisfy red tape demands of government;
  4. the bribes paid to "consultants" who negotiated the zoning changes for the developer;
  5. Government money grabs, eg infrastructure charges \$60,000 per new home;
  6. Developer profits for doing the work, \$60,000 fees paid become \$90,000+ added to the cost of producing the house and land package, bribes plus profit margins, red tape plus profit margins.
- volume. For each house block this is about \$1000. The road base costs about \$2000 per building block. The edging about \$2000, the water \$500, the sewage \$3000, underground electricity \$500, communication cables \$500. The actual outlays and materials required to produce a house block costs \$11,500.00.

### Now comes the rip off:-

Then we have to add the costs of surveys, plans, Planning consultants, application fees and charges, all the red tape and charges bring the land package cost to \$60,000. But the land sells in the range of \$160,000 to \$350,000. On this basis there must be a bribe or rip off excess profit of about \$100,000.

### The horse-thieves take about \$100,000.00 on every house block.

The pricing structure indicates significant criminal activity. Bribes and favours for zoning changes. We need to know what is really happening to drive the price of homes from 2.5 times the average wage ten years ago to 6+ times the average wage now.

Check it for yourself – what does it cost to produce a suburban building house site?

What does it really cost to produce a building block? The land banking / developer paid less than \$2000 per building block for Yarrabilba land. Asphalt costs from \$15 to \$18 per square meter to lay in

would have had this stroke. That Geraldine was not prescribed blood thinners was pure negligence making if foreseeable that Geraldine would die from a major stroke. Thus Logan Hospital is legally and

financially liable for the death of Geraldine Robertson. The Logan Hospital, by their negligence, [or intention?] deliberately set Geraldine up to die from a massive stroke. But it gets even worse! A dead person can

not sue for damages. Logan Hospital has a fiduciary duty and that hospital has breached their fiduciary duty to Geraldine by knowing she was in need of blood thinners and not prescribing them and not

# Clare Endicott, QCAT Senior Member – Human Rights, is **corrupt**



QCAT's Clare Endicott

My [Russell Mathews'] personal experience [16<sup>th</sup> April, 1992] with this parasite's dishonesty amounting to CRIMINAL perversion of the course of justice, has been supported by the Qld's Court of Appeal decision in *Maher v Adult Guardian & Anor* [2011] QCA 225 (11/3174) Chesterman and White JJA and Philippides J 9 September 2011. In that case the Court of Appeal found that Clare Endicott had engaged in apprehended bias and QCAT had engaged in secrecy surrounding her sitting on the biased appeal before Endicott. That was more than five years ago, and Endicott is still there, in the QCAT portion of the Queensland corruption sewer.

In 1990 I was set up by bogus written complaints by feminazis to the Human Rights and Equal Opportunities Commission [HREOC] then under the direction of Quentin Bryce. Clare Endicott, was the Town Agent for HREOC.

It went to a hearing in 1991, before another corrupt but dumb turkey Kevin O'Connor. HREOC prejudiced the hearing by giving O'Connor secretly, without my knowledge and without my seeing it, a "black vinyl folder" of what they called "background information" which was just fabricated allegations of wrong doing by me. At the time I would have realized that that was unfair to me. When I was studying Admin Law in 1994, at The University of Qld, for my LLB, I discovered that that

secret written prejudicial material, made the decision of O'Connor [which of course was adverse to me – their pre-determined result] was *ultra vires* and *void ab initio* [ie totally unenforceable, as if it did not exist].

I appealed that decision of O'Connor to the Federal Court. It was set to be heard starting Wednesday 22nd April, 1992. Friday 17<sup>th</sup> April, 1992 was good Friday. As a result, HREOC had to serve me with their court documents on Thursday 16<sup>th</sup> April, 1992.

The documents were mainly the affidavit of a John Joseph Armstrong who as "counsel assisting" O'Connor was a party to the corruption before O'Connor. The affidavit was three pages but there were about 1,000 pages of annexures to the affidavit. The "black vinyl folder" which he called "background information" was Exhibit JJA3.

Had I been able to read the affidavit and JJA3, I would have seen how HREOC had prejudiced the hearing coram O'Connor. I would have brought that to the attention of Spender J. [another corrupt parasite] at the beginning of the hearing.

I should have had all of the four days of Easter and the Tuesday to scrutinize that affidavit and been able to read the precise contents of JJA3 including the bogus false allegations about me. Spender would have had no option but to call the hearing coram O'Connor as *ultra vires* and I would have won. They did not wish that to occur.

Clare Endicott rang me on the Thursday, 16<sup>th</sup> April, 1992, with the excuse that because they were having trouble photocopying they would not be able to serve me before 5pm that day. I said I was prepared to remain late, [I lived on the premises]. She was silent for a while then spirited out, that I would not be served that day but on Tuesday next, the day before the hearing was to commence. Clare Endicott

later lied in writing the reason that I was not served on that day. The reason she gave, as is typical for a feminazi whore for law, was that I had purported that it was inconvenient for me to be served on the Thursday. Just consider the logic of that. I lodged the appeal. I really wanted to know all I could of what they had done, and what their case was.

The reason that these feminazi parasites wanted to serve me late, was to prevent my reading it to discover that the decision maker Kevin Patrick O'Connon was given the fictitious fabricated complaints against me, when I did not know of them, and that he made his decision based upon them. That was the FEMINAZI WHORE FOR LAW SET-UP. There were over 1,000 pages in all the attachments to the affidavit. By legal precedence, the giving to a decision maker of prejudicial "evidence" in other than verbal, makes his decision *void ab initio* [void and unenforcible from the beginning and nothing can resurrect it]. Although, at that time I did not know of that legal precedence, I would have brought it to the attention of the judge, had I known of it.

On the last or second last day of the hearing, I did realize that O'Connor had documents presented to him, when those prejudicial documents were unknown to me, and I mentioned it to Spender, who hesitated for a short time, but then continued.

Importantly, Clare Endicott made another major lie to me when she phoned me, and that was that I would not be disadvantaged, as there was nothing in the file that was unknown to me. That was also a mammoth lie.

If you have this parasite, this feminazi whore for law, Clare Endicott, as a decision maker in your matter before QCAT, you can expect that the establishment party will win, and you will lose.

## Letterbox distribution of written TRUTH WORKS

drain that had been filled in. This is a country road where there is no room for pedestrians as that room is taken up with an unnecessarily deep and large drain. Each year the Council has cleaned it making it larger till it is ridiculously large for the amount of water it carries.

With more rainwater tanks and especially many smaller agricultural and pastoral dams upstream, mostly on private land, there will be a reduced need for larger dams downstream, which dams would be at a substantial cost to taxpayers.

As the total capacity of all tanks and dams on property increases, there is less stormwater to flow downstream so causing flooding, and the cost and fatalities of flooding.

Despite the mitigation of floods benefit of an increased number of agricultural dams, the Logan City Council, has, in their 'wisdom' decided to charge ratepayers \$10,000 for the right to construct such a dam. It really is a matter of the little minds of public sector parasites deciding they have the power to bully ratepayers.

In fact, encouragement of an increased number of rainwater tanks and stormwater dams on rural properties not only mitigates flooding but also improves drought proofing of regions and states downstream.

It seems when people are elected they become avaricious idiots.

Logan Mayor Luke Smith is so mean spirited he will not allow people on rural properties to access the water running away beside the roads

past their own land, to fill their dams. Trevor Croll dug a drain from the roadside drain to his dam only to have Logan City Council come along and

fill it in and pack concrete blocks into it making it so much more difficult to repair. There was a drain to the road

properly advising Geraldine of her condition and what it meant. Geraldine could claim \$millions from Logan Hospital.

In hospital Geraldine Robertson could communicate by blinking. She was initially unable to speak or make any noises. After about 4 days Geraldine had begun to vocalise and move her legs which is the beginning of recovery. This was seen by Trevor and reported to Trevor by other patients. Trevor was

told the stroke hit her in her brain stem and thus her brain couldn't communicate with her body. Brain neurons are known to rewire themselves after a stroke so there is always a good chance of a good recovery.

Dr Sze Yan Sallyanne Chan, a member of Geraldine Robertson's treating team at Logan Hospital had suggested to Trevor that Geraldine would not recover but Trevor wanted her to be given a chance to

recover. Logan hospital and the Annastacia Palaszczuk government did not. Trevor did not agree to palliative care. Geraldine Robertson had given Trevor Croll an enduring power of attorney so he could act for her and make decisions for her if she became disabled.

This is when it got much worse for the Labor Government and Logan Hospital. It seems that Dr Sze Yan Sallyanne Chan decided to kill Geraldine by

drugging her to the eye balls thus disabling any chance of recovery. This killed her. That it was deliberate is what the actions and evidence suggest. Logan hospital did not want Geraldine to recover.

Dr Sze Yan Sallyanne Chan, a member of Geraldine Robertson's treating team at Logan Hospital, swore under oath that the information she provided to QCAT was true to her knowledge and said Dr

David Roberts (General Physician) had approached her to fill in a form "Report by medical and related health professionals - Guardianship and Administration Act 2000." In this form section 5.1 Dr Chan states "Patient is unable to understand, retain, or communicate personal health care decisions due to disability from the stroke". A stroke she later perjured was caused by her head being twisted damaging her brain stem causing a blood

<p>clot and stroke.</p> <p>In Section 4.1 of that form Dr Chan said Geraldine Robertson had previous presentations for transient ischaemic attack (TIA) also known as micro stroke. Geraldine was not advised of this. When people get these they are put on blood thinners to prevent a fatal outcome. Geraldine Robertson was never prescribed blood thinners or properly advised of her condition.</p> <p>For Trevor's enduring power of attorney to be revoked it had to be shown that Trevor would not act in Geraldine's best interests.</p> <p>Dr Chan lied to QCAT that Geraldine Robertson's head had been twisted by her husband, damaging her brainstem and causing a clot. Dr Chan said her husband had been out of town for a few days, indicating the violent twisting of Geraldine Robertson's head had occurred, then her husband left, then he came back and called an ambulance and that he knew how to do these things and what he had done. Dr Chan also verbalised Trevor Croll throughout her report saying he said things that he did not say. The QCAT hearing happened without Trevor's knowledge and was a dirty underhanded malicious attack on Trevor and Geraldine. It is a denial of due process aka denial of natural Justice and procedural fairness.</p> <p>Dr Chan's mistake was assuming Trevor had been "out of town for a few days". In fabricating their story of lies they made a mistake. Trevor had left, driving to Victoria on Friday morning the 22nd July 2016 and had arrived back and discovered Geraldine in her disabled state on Saturday evening on the 30th July 2016.</p>	<p>That is eight days later.</p> <p>It was proven Trevor Croll could not have murdered Geraldine Robertson. If the lies told to QCAT were believed there is a murderer out there who goes around to old ladies homes and twists their necks damaging their brain stem with subsequent clotting then leaves them crippled to die slowly. If you smell death in your street call the Police, there is another murdered old lady rotting in her home.</p> <p>To put Geraldine Robertson down the hospital needed her husband's Power of attorney to be revoked and lied that Trevor "will not act in her best interests". Trevor had obtained an enduring power of attorney four years previously due to Magistrate HALL assisting RSPCA by declaring Geraldine mentally unfit while she was personally and successfully prosecuting RSPCA for stealing, lying in court, and fabricating evidence.</p> <p>There had to be a 'justification' before the enduring power of attorney given by Geraldine Robertson to her husband could be revoked by QCAT.</p> <p>"Luckily" or by design this application was decided [in secret, and without any personal appearances] by corrupt femi-nazi, Clare Endicott. See page 3 article, "Clare Endicott, QCAT Senior Member – Human Rights, is corrupt".</p> <p>Senior Member Endicott made the decision to appoint the Adult Guardian (Robert Davie from OPG Robert.Davie@publicguardian.qld.gov.au and 07 3884 6664) who also is responsible for Geraldine going into palliative care and Public Trustee for</p>	<p>Geraldine Robertson. Rebecca McKimmie Rebecca.McKimmie@health.qld.gov.au urgently sought Robert Davie to approve palliative care.</p> <p>Geraldine Robertson was put down with Aspirin 100mg, Paracetamol 1 gram, piptaz 4.5 gram, amlodupine 5 mg, nilstnt 1ml, amlodipino 10mg and probably other drugs closer to the time of her death within about 7 days. These drugs turned her brain off so they could kill her body. Geraldine died on the 23 August 2016. The Logan Hospital denied her her chance to recover and be alive.</p> <p>Trevor Croll had been paying Geraldine Robertson's Private Health Insurance for the previous six years. The Logan Hospital refused to apply this private health insurance to Geraldine's condition and possible recovery. Trevor wasted \$9,000 + on Geraldine's private health insurance.</p> <p>Geraldine Robertson was misled into blaming her husband for her health problems which she called panic attacks. This blaming caused domestic stress for her and aggravated her tendency to anxiety and high blood pressure.</p> <p>Geraldine was denied a proper diagnosis and deliberately not prescribed medication recommended for people having TIAs that would save her life. And I am still waiting to read the Coroners report on this. Why is the Coroner taking so long to report on this? Trevor says he has come to expect a cover up based on his previous experience with Queensland Labor Governments.</p> <p>When Geraldine had her stroke</p>	<p>the hospital went to QCAT with lies to get control with the adult guardian (Geraldine comes from a very, very, very, wealthy Malaysian Chinese family) and was then put down / murdered by that hospital.</p> <p>Her husband was set up for a murder charge which the hospital expected would have put him in prison on remand and then sentenced to prison for 20 years on their lies.</p> <p>Trevor was just very lucky, if he had been in Brisbane at the time he would have been in prison on remand and then convicted for murder on the lies of a doctor.</p> <p>But this is a crime that will never be remedied. The Queensland Courts protect false witnesses who lie for the prosecution and they are never prosecuted. Every case for damages are automatically dismissed on the basis that it is against public policy to allow cases like that to continue. production of vitamin D. Google "vitamin D wellness", the best time is a simple 20 minute walk in the sun from times 6:00AM to 9:00AM and avoiding the midday UV damage. If you are going to do an examination or a job interview, you should always get some morning sun before attending. Also don't test for this if you are doing the "Take a teaspoon of bi-carb" test on the same week.

# How to fight cancer

Background. Some more pieces to the puzzle

My father died of cancer and before he died, I set out to understand cancer with the purpose of saving him. I was too late.

What I learned about cancer is it is a failure of our immune system to protect us from cancer. It has elements of genes increasing vulnerability to cancer and viruses damaging cellular dna increasing the cell's prospects of becoming cancerous.

Good nutrition can improve our immune system. Immune cells normally recognise cells that have gone bad and kill and eliminate them from our body. Cancer is a condition where the rate of spread of the bad cells is faster than the immune system can repair the damage by removing bad cells. The pustules of herpes, small pox and other such viruses are not caused by the viruses. **1. Starve the cancer. Google "starve cancer".** Cancers are over active cells running at high energy levels increasing their populations at a fast rate. When a fire is smothered the fire goes out, the getting rid of the by products of metabolism is very important and allows the system to function much better. I have read many times the statement that cancers thrive in acid environments. Increasing pH lowers the acid in the body and improves fitness and general body health. problems such as sensitive teeth, chronic fatigue, low energy, and other general un-wellness comes when our system becomes too acidic. Do the test. Take a teaspoon of bi-carb of soda with a magnesium pill available from any health shop or Woolworths and Coles. Wait 4 hours and then ask "do I feel much better". If the answer is yes then your system WAS too acidic and you should continue to take a magnesium with bi-carb of soda several times a day for about a week. Note you can purchase urine test strips which can measure urine ph and using this measure take bi-carb of soda with a magnesium as many times a day to keep your urine close to pH neutral (7).

**3. Improve the immune system and general health. Google "brewers yeast immune"** Feed your immune system, it is our army fighting most disease. The doctors examined the benefits of taking Epicor™ brewers yeast and found that it dramatically improves the immune system. Now they sell their brewers yeast as "Epicor" and hide the fact it is in fact common brewers yeast available from any health food shop. **4. Reduce inflammation as this reduces the spread of the disease. Google "cancer inflammation".**

The ulcer bacteria is known to cause cancer because its action of feeding off the stomach causes a constant open sore with inflammation. Untreated inflammation can result in cancer and speeds the spread of cancer. The foods we should avoid can be discovered by - Google "inflammatory foods". The foods we should increase - Google "anti-inflammatory foods". Flax seed oil is especially good at reducing diseases including auto immune diseases.

The immune system is like the Americans at war, there is friendly fire. Cells die in two ways, they commit suicide by enabling their suicide genes or they die and rot. Rotting cells alarms the immune system with the consequence that rotting cells are removed and other cells near by get damaged and die and rot and the inflammation and disease continues. Cancer is a disease of our genetic code. DNA has the capacity to multiply cells in our body. It is when it goes out of control that it becomes a tumor or cancer. For this process to occur many genes must function together. Block several genes and the cells may not be able to be cancerous. Take the block away and the cells will become cancerous again.

**5a Google "feverfew cancer"** In 2003 a friend's best mate (John Williams) after 3 chemotherapy treatments the last with stem cell replacement

had been told by the doctors they could not save him and sent him home to die. I bought a bottle of feverfew and gave it to my friend who gave it to his wife. The results of the next test was "you are cured - its a miracle". John survived another 12 years until an accident with a lawn mower and petrol caused him to become seriously burned in April 2015. Other friends of mine have also been cured with just fever few.

I read a research paper in 2003 and the drug that was developed from feverfew was trialled in Australia in 2015 but it is too expensive for the PBS. Feverfew blocks two genes essential for cancer. I cannot say it works for all cancers and the research paper suggested it should work for at least 50% of cancers. Take 2 to three teaspoons the first day and then one teaspoon a day and see how things improve for your next cancer test. Do not tell doctors because they will do every thing to talk you out of taking it. The drugs industry is a cartel taking money from people and any threat to their dominance is ruthlessly routed out.

**5b. Google "job's tears cancer treatment"** Also known as Chinese pearl barley and coix lacryma-jobi.

Apparently this is a crop that is a weed in rice fields but because it has a grain it has been tolerated. In some places in China it grows better than rice and where it is the staple Chinese Doctors never see cancers. **Google "kanглаite".** Kanглаite is an extract of job's tears and comes as a white milk. I have personally spoken to and been there when some patients, having imported kanглаite from China, were having it put into their blood stream by IV. One lady in her 50's explained to us she had had breast cancer then 5 years later had pain which was later diagnosed as bone cancer and after treatment was told the doctors could not save her. She told us that with this kanглаite her cancer count had been dropping every session and her pain had gone. The research paper I read indicated kanглаite blocked two cancer genes called COX1 and COX2. Having half a cup of Chinese pearl barley in your diet will be a definite help. Suggest soak for half a day, then blend in water to a milky liquid, then add to stew or with other cooking ingredients.

**Google "apricot kernels" also Google "laetrile".** and Vitamin 17. Laetrile is an extract of Apricot kernels. I met two men both at an IV clinic in Camberwell Melbourne having hair tonic added to their IV drip going into their veins. They explained that the Customs had confiscated their laetrile so they had the supplier call it hair tonic to get it through Australian Customs. Both were regulars at this clinic. Both reported to me that their cancers were curing. One was still taking chemotherapy which he said had not working then secretly coming to this clinic to their laetrile IV. I have come across many others who have also claimed the benefits of apricot kernels. The drug industry employs people to put misinformation into the internet. I have read that one should not take more than 25 apricot kernels. This is a lie. In Europe Northern countries where apricots were a staple apricot kernels were also a staple in their meals and they ate it like people would eat any other vegetable or food. Preparation: Suggest use blender with small half cup of kernels and add olive oil then blend. Apricot kernels are very oily so blending in oil is very effective. Then use it like putting butter on other vegetables.
